## **1.0 General Background**

Nature Trust Malta is requesting quotations for services in relation to the creation and production of a Stewardship Agreement to be used in connection with the COASTRUST Project. The project is co-financed by the European Union, under the Interreg Euro-MED Programme.

### *1.1 Project Description*

#### **The COASTRUST Project**

The Mediterranean basin is considered amongst the most important biodiversity hotspots globally in terms of ecosystem and species richness. Human related activities, such as the most impactful; Overfishing (48%), Habitat destruction (26%) and Pollution (13%), have put significant pressures on nature, and is thus resulting in ecosystem degradation and alarmingly rapid species loss across the med. Anthropogenic activities paired with Climate Change has led to an urgency for immediate intervention at a co-ordinated transnational approach.

The COASTRUST project addresses small-scale strategies promoting sustainable use, management, protection/restoration of species, habitats/ecosystems, made possible with the involvement of local-level citizens and stakeholders from related economic sectors, all in accordance with the European political framework that promotes a voluntary participatory approach.

The project focuses on an environmental stewardship as a voluntary multistakeholder governance mechanism at a community level, that supports the management of natural, cultural and landscape values on land and sea. It includes the participation of 9 project partners and a total of 7 participating countries: Albania, Bosnia and Herzegovina, Croatia, Greece, Italy, Malta, and Spain.

This marine stewardship will be piloted in different target areas, varied coastal habitats in the aforementioned countries, all of which requiring unique methodology and a series of activities to operate strategically, according to their individual environmental and stakeholder needs. It applies environmental management in areas heavily influenced by anthropogenic pressures, resulting in the establishment of multi-stakeholder management mechanisms. Protected areas are an important conservation tool, yet their success and effectiveness may be compromised by lack of engagement and poor policy. This management tool facilitates collaboration and efficient harmonization across nations towards promoting biodiversity. Ultimately, the aim is also to openly share the COASTRUST approach and pilot methodologies beyond the scope of the project, aiming to benefit other Mediterranean citizens in reaching common environmental goals.

#### **Nature Trust Malta at the Ċirkewwa Marine Park**

Nature Trust Malta is a non-profit, non-governmental, environmental organization working in the Maltese Islands, as well as a privileged partner of World Wildlife Fund (WWF). The organisation is carrying out many environmental projects in Malta such as afforestation, habitat conservation and the creation of marine protected areas, all of which are aimed to help conserve the Maltese natural heritage. Nature Trust manages a marine park and several land-coastal conservation sites, and therefore it has a direct interest in the objectives of the project,

especially given the small size of Malta and the resulting closeness and pressures exerted on natural heritage by economic activities.

The COASTRUST project presents an important opportunity for the Trust to work in collaboration with different partners through the allocation of the pilot area at the Ċirkewwa Marine Park, and over the duration of the project has been addressing the involvement of different stakeholders, to further encourage ownership and responsibility by the community at large for the well-being and conservation of our coastal natural heritage.

The trust has undertaken varying stakeholder engagement activities in the local pilot area of Ċirkewwa Marine Park, on the Northwest-most point of the island of Malta. These activities have led to the understanding of planned further actions based on experience gained in the management of the area, and on the associated in-depth knowledge of the needs, availability, and potential of necessary resources, as well as the in depth contribution from many stakeholders through the activities run. After participating in varying stakeholder activities some key pilot actions for the COASTRUST project to focus on were established, as well as the leading priorities within the Park. These priorities are being turned into Stewardship Agreements with the local stakeholders. These Agreements need to have a legally binding contract and document to tie the stakeholders undertaking the stewardship activities with the Ċirkewwa Marine Park. Those documents are what this request for quotation is for.

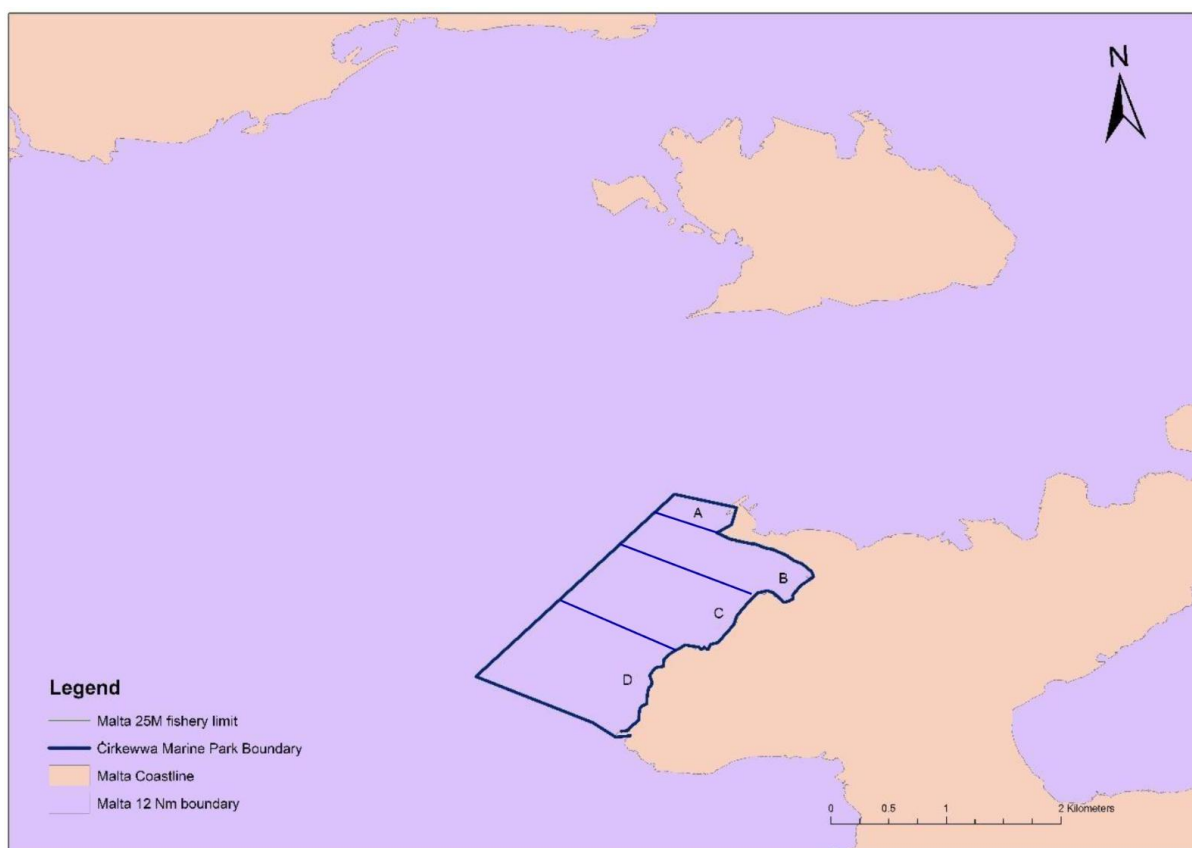
The Trust will promote the participation of stakeholders beyond the duration of this project, and encourage and ensure continued involvement of the partners.

## 2.0 Contract Objectives and Expected Results

### 2.1 Overall Objectives

The overall objectives of the COASTRUST project of which this contract will be a part are as follows:

1. Establish environmental stewardship strategies in target areas as multistakeholder governance mechanisms.
2. To protect biodiversity.
3. To sustainably use natural resources.
4. To support the management of natural environments at land and sea in coastal areas.
5. To release a methodology on the tested approach for transferring and replicability.

### 2.2 Specific Objectives of the contract

The specific objectives of this contract are as follows:

- To create a Stewardship Agreement document that can be used to contractually designate certain activities to the ownership of varying stakeholders for a certain duration of time.
- To create contractual agreements to support each Stewardship Agreement between the stakeholders and the Contracting Authority.

### *2.3 Expected results*

Results to be achieved by the Contractor are as follows:

Production of three Stewardship Agreement documents to be used to finalise the engagement of stakeholders into pilot stewardship actions for the Cirkewwa Marine Park.

Production of three contractual documents to support the Stewardship Agreements to give more detail of the contractual engagement.

### *2.4 Specific Activities*

The contractor shall perform the following activities:

#### **1. Create three documents that can be used as legally binding Stewardship Agreements between single or multiple stakeholders and the Contracting Authority.**

The contractor will work with the Contracting Authority to determine the contents of each Stewardship Agreement as per each stakeholder/stakeholders that need to be engaged with each Stewardship Agreement.

The first Stewardship Agreement will detail:

An agreement between multiple stakeholders who will act as stewards, with the Cirkewwa Marine Park for the Marine Park's ongoing Citizen Science projects. This will include but not limited to, organisations and individuals volunteering to brief clients and dive customers, supporting them to fill out Citizen science submissions on site, discussing the importance of Citizen Science, and contributing to the ongoing projects where possible.

The second Stewardship Agreement will detail:

An agreement between one or more stakeholders who will act as stewards, with the Cirkewwa Marine Park for the Marine Park's required underwater Fish Surveys. These fish surveys will follow a structured zoning, and depth pattern that mimics previous surveying to act as a comparison. Surveys will be undertaken using specific methodology and equipment as defined in the contractual agreement.

The third Stewardship Agreement will detail:

An agreement between multiple stakeholders who will act as stewards, with the Cirkewwa Marine Park for the use of educational communications regarding the Posidonia Meadows within the Cirkewwa Marine Park. This will include but not limited to, briefing clients and customers, discussing the importance of Posidonia, and giving out or sharing educational materials.

#### **2. Create three documents that can be used as legally binding contractual documents between single or multiple stakeholders and the Contracting Authority for each of the above Stewardship Agreements.**

## *2.5 Project Management*

The final beneficiary responsible for managing the service contract is the Nature Trust Malta, Malta.

## **3.0 Requirements**

### *3.1 Key Experts*

The Contractor shall engage adequate expert/s to fulfil the following profiles:

- An experienced document creator for EU Projects to ensure project requirements are fulfilled.

Since the contractual documents are binding documents in Malta, there must be some consultation to ensure Maltese legislation is adhered to and the documents are valid as contractual documents. All documents must be delivered in English, so a fluency in this language – both written and spoken - is required. A Curriculum Vitae (CV) of any proposed key expert needs to be submitted together with the offer.

### *3.2 Equipment*

No equipment is to be purchased on behalf of the Contracting Authority as part of this service contract or transferred to the Contracting Authority at the end of this contract.

### *3.3 Reporting*

A final progress report and a final invoice shall be delivered at the end of the period of execution. The report must be written in English. One copy of the final report must be submitted to the Project Manager identified in the contract, who is responsible for its approval.

### *3.4 Monitoring and Evaluation*

Specific performance measures have been chosen to provide valid, useful, practical and comparable measures of progress towards achieving expected results. These will be mainly qualitative and consist of judgements and perception derived from subjective analysis by the Contracting Authority. The Contracting Authority has the right to appoint suitably qualified persons to evaluate the deliverables and results of the service. The measures considered shall include, but are not exclusive to:

- Respect of service deadlines as specified in the contract or by agreement between the service provider and the contracting authority.
- Validity of the service undertaken and the quality and suitability of the documentation.
- Quality of the reporting.

### *3.5 Commencement Date & Period of Execution*

Performance of the Contract is to commence with immediate effect post notification of the confirmation of the allocation of this engagement. The time-limits for the execution of the contract shall take into consideration the following project requirements:

All documentation needs to be completed within two weeks of the confirmation of this contractual engagement.

### *3.6 Location*

The work required for this engagement can be undertaken from anywhere, as seen fit by the Contractor.

## **4.0 Selection of successful bidder**

The selection of the successful bidder will take place in line with the Public Procurement Regulations (LN 296 of 2010) and its subsequent amendments.

## **5.0 Submission and Contact Details**

Quotations are to reach NTM either by email (gayle@naturetrustmalta.org), or they may be deposited in the tender box during office hours before the 13<sup>th</sup> February, 2026, at 11:00.

All prices must quote VAT separately and in full. For payment purposes, invoices and receipts should be issued accordingly.

In view of the project funding available, quotations which exceed €5,000, exclusive of VAT, will not be considered.

## **6.0 General Conditions**

1. The contractual relationship between parties will be a supplier-customer relationship, based on a professional and reliable customer service.
2. NTM may terminate the contract should any of the deliverables not be of the required level and quality matching the standards of NTM.
3. Authorship of the work contracted in this RFQ may or may not be credited at the discretion of NTM. Additionally, NTM remains the sole and exclusive owner of all IPR for all of the deliverables.
4. The selected supplier will not issue any press releases, publicity or any form of communication that relates to this agreement or suppliers relationship with NTM.
5. The selected supplier is expected to act correctly in all its dealings with NTM, avoid conflict of interest, protect NTM property and information, commit to Health and Safety

Regulations, Security Standards and Environmental Protection.

6. All information submitted as part of the Offer will be treated in strictest confidence. Any attempt by a bidder to obtain confidential information, or influence NTM during the process of examining, clarifying, evaluating and comparing the RFQ documents will lead to the automatic rejection of the relevant proposal.
7. NTM reserves the right to cancel this process without it incurring any penalty or cost or any liability however so described.
8. NTM may, at its own discretion, decide not to select any proposal even the most advantageous offer.
9. NTM may, at its own discretion, decide to select a subset of the proposal or conduct the implementation of the proposal in stages over a period of time.
10. NTM reserves the right not to consider offers that have missing mandatory information.
11. NTM may disqualify the bidder completely if it does not abide with the above instructions.
12. The information collected shall be processed in accordance to the Data Protection Act (Chapter 440 of the Laws of Malta). The submissions to this RFQ are confidential and intended solely for the use of this RFQ process, and will not be disclosed or copied without the consent of the applicant to anyone outside NTM unless the law permits us to.
